




INTRODUCTION

The role of the Office of Multicultural Interests is to assist the Western Australian Government to achieve the full potential of multiculturalism. Fairness, equality, participation and civic values are the core principles at the heart of the State's multicultural policy which is articulated in the WA Charter of Multiculturalism.

The Western Australian Multicultural Policy Framework, launched in 2020, translates the Charter's principles into three key policy priorities:

- Harmonious and inclusive communities
- Culturally responsive policies, programs and services
- Economic, social, cultural, civic and political participation

These principles and policy priorities are the basis for the *Office of Multicultural Interests Strategic Plan 2023–2026.*

Support the public sector to fully implement the WA Multicultural Policy Framework

Develop and promote initiatives to address inequities in service access or policy outcomes, including advocating for the collection and use of data to guide program and policy development

Engage with culturally and linguistically diverse communities and relevant agencies to enable meaningful community involvement in the design, delivery and review of policies, programs and services

Support provision of settlement assistance and services that effectively meet the needs of migrants, refugees and people seeking asylum

Promote the use of language services and the development of cultural competency

Fund and support community associations and specialist service providers to lead and deliver services that meet the needs of Western Australians from culturally and linguistically diverse backgrounds

Outcomes


Western Australians from culturally and linguistically diverse backgrounds can participate equitably in cultural, social, economic, civic and political life



OUR TERMINOLOGY

Multiculturalism, as a policy defined in the WA Charter of Multiculturalism (the Charter), is about all of us.

It recognises that difference is a feature of any society. In addition to culture, language and religion, there are differences such as in gender, age, disability and socioeconomic background. What binds us is our commitment to our country and its laws, principles and practices.

It recognises that our multicultural community includes everyone, and that Aboriginal people have a unique status as Australia's First Peoples.

Fundamental to the Charter are equality of opportunity, equitable outcomes, and mutual respect. These are reflected in the Charter's four principles:

- Civic values Mutual respect, individual freedom and dignity for all members of society and a commitment to the laws and structures of Australia
- **Fairness** Public policies free of prejudice, discrimination and exclusion on the basis of origins, perceived 'race', culture, religion, ethnicity and nationality
- Equality Equal opportunity for all members of society to achieve their full potential
- Participation Equitable participation for all Western Australians in all aspects of life

Culturally and Linguistically Diverse (CaLD) applies to groups and individuals who differ according to religion, language and ethnicity, and whose ancestry is other than Aboriginal or Torres Strait Islander, Anglo-Saxon or Anglo-Celtic.
