CONDITIONS OF USE FOR THE 'CONNECT' LOGO

The role of the Office of Multicultural Interests (OMI) is to promote the achievement of full participation for all members of Western Australia's diverse community.

The Office of Multicultural Interests aims to assist and encourage the involvement of all Western Australians in projects and events that promote the inclusion and active participation of Western Australians from diverse linguistic, religious and ethnic backgrounds.

Projects and initiatives which request the 'CONNECT' logo shall aim to achieve one or more of the following:

- Increase representation of members of culturally and linguistically diverse (CaLD) communities in all aspects of social, economic and political life.
- Encourage mutual respect between individuals and communities and facilitate positive interaction among people of different linguistic, religious and ethnic backgrounds.
- Strengthen the capacity of CaLD communities to develop and sustain programs that respond to the needs of individual and community needs.
- Promote the benefits of cultural diversity and the contribution of individuals and communities from CaLD backgrounds to the Western Australian community.

CONDITIONS OF USE

The 'CONNECT' logo will be provided under the following conditions:

1. To promote OMI funded projects during Harmony Week.
2. To promote non-OMI funded multicultural projects during Harmony Week.
3. To promote an OMI funded project through the Community Grants Program.
4. To promote an OMI sponsored project.
5. To support a project that is considered appropriate by OMI.

Use of the 'CONNECT' logo

1. Must be used in conjunction with Harmony Week 2008 (date as applicable) or Multicultural Western Australia graphic designs as supplied by OMI.
2. Must be used in conjunction with the WA Government Common Badge.
3. Non-Government initiatives displaying the CONNECT logo and WA Government Common Badge must indicate the initiative is '*sponsored by*' OMI.
4. No other slogan or wording can be used in conjunction with the CONNECT logo unless otherwise approved by OMI.

Written permission is required to use the 'CONNECT' logo under all circumstances OMI reserves the right to approve the use of the 'CONNECT' logo or to withdraw permission for use of the 'CONNECT' logo should the event or initiative be considered in conflict with the aims of the brand or the interests of the State Government.
