Selected 2011 Census data on cultural and linguistic diversity in WA

Peppermint Grove Local Government Area

According to the 2011 Census, the Peppermint Grove LGA has a total population of 1,533 people:

- 23.8% were born overseas
- 9.6% were born in a non-main English speaking (NMES) country
- 8.1% speak a language other than English at home.

Ancestry is calculated as:

(Total – Not Stated = Fixed Figure).

Percentages are calculated by dividing each variable by the fixed figure, consistent with ABS methodology.
